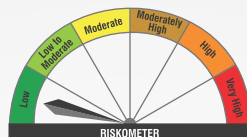

Tier 1: CRISIL Liquid Overnight Index

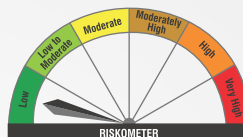
